

Attention Juniors & Seniors!

Open Campus for 2nd Semester

The last day to turn in forms will be **February 11th, 2016**

Open campus is a privilege available to **Juniors & Seniors** meeting the following requirements:

1. No more than 3 days on which an unexcused absence is recorded from the previous semester
2. No in- or out-of-school suspensions in the previous semester
3. No marijuana/alcohol/or drug infractions within the previous year
4. Parent permission
5. Completed paperwork

How to apply for Open Campus:

1. Sign-ups for 2nd semester Open Campus passes are **February 4th- 11th, 2016**
2. Pick up an application on the Jackson Scoop Wall or
Print one from the JHS Website under>Our School>Policies>Open Campus Policy
3. Complete and return paperwork, by the deadline, to the box marked **Complete** on the Jackson Scoop wall
4. A JHS identification card or ASB card is required
5. If you qualify for Open Campus, Mrs. Monten or Coach Nick will affix an Open Campus sticker to your ASB/identification card
6. Open campus stickers will be distributed to students, during lunches, **February 17-19 in Mrs. Monten's Office B212**
7. You must show your Open Campus sticker on your ASB/identification card when leaving campus for lunch

Reasons Open Campus will be revoked (not limited to these examples):

1. Late to or absent from the class following lunch more than 3 times in a semester
2. Drug/alcohol/tobacco use off campus during lunch
3. Littering at restaurants or other locations while off campus
4. Suspension from school
5. Lending your pass to others
6. Forgery or creating a false Open Campus pass
7. Taking students who do not qualify for Open Campus off campus

I believe that my student understands the responsibilities that accompany this privilege, and I agree that he/she will fulfill them.
