Completed applications must be signed by an Administrator and ticket must be purchased by the end of lunch on the Thursday prior to the dance. No applications will be accepted after this time. **This form must be completed and signed by the Administrator prior to purchasing dance tickets. NO guest passes will be accepted at the door.**

Students bringing a guest to a Cascade High School dance must abide by the following regulations:

- Students are only allowed one guest.
- Attain a CHS administrator's signature before purchase of guest ticket.
- **Guest tickets must be purchased no later than Thursday, April 27, 2017 at the end of 2nd lunch.**
- Student must enter and leave with his/her guest.
- Guest must show student photo ID card from his/her school.
- Middle School students may not attend High School dances. NO EXCEPTIONS.
- Guests that do not attend high school must show a current photo ID (i.e. driver's license).
- Cascade High School students are responsible for the behavior and demeanor of their guests. Cascade High School students are responsible for informing guests of all CHS behavior and dress code rules.
- Each pass is verified for accuracy. Any forged signatures result in forfeit of dance attendance by CHS student and his/her guest. The CHS student may receive discipline up to and including suspension.
