## **Special Ed and 504 Resources**

At minimum, Special Education is impacted by:

- federal law (Individuals with Disabilities Education Act, a.k.a. IDEA; Section 504 of the Rehabilitation Act of 1973; Elementary and Secondary Education Act, aka ESEA; Americans with Disabilities Education Act, a.k.a ADA) and regulations,
- state law and regulations (which must meet the minimum standards set by federal law and its regs),
- district policies and procedures (see Policy 2161 and Procedure 2161P; Policy 2162 and Procedure 2162P covers 504 plans),
- administrative law hearings and court cases related to all the above and how they are carried out

No wonder it is hard to keep up with what is relevant for your child's education services! So to assist you in being your child's best advocate, I've listed some resources.

Everett SLO resources—just ask me to email you the item or give you a copy. Call or email me with questions and concerns!

- Organizing Your Special Ed Records—easy to do; I'll even sit with you and we can do it together—just bring in your box/bag/envelopes of records
- Comparison of ADA, 504, and IDEA—compares type of law and purpose, whether it addresses Free and Appropriate Public Education (FAPE), funding sources if any, procedural safeguards, evaluation and placement procedures, and due process
- Student Centered Process—helps you plan and share info for 504 or IEP or any meeting about your child. Sections are Strengths, Concerns, Goals and Objectives, Services Needed, Placement(s). Frequently just doing the first 2 sections are enough to generate lots of discussions about your child's education.

Google is your friend! You can search for information on the type of disabilities that your child may be facing. There are organizations that provide support for autism spectrum disorder, specific learning disabilities, Down's Syndrome or other specific syndrome or genetic disorder. This is great way, learn more about the disability and education options, as well as to network with parents and locate specialists.

There are free e-newsletters on topics of special needs, so you can learn as you scroll and stay current on issues.
