MESSAGE FROM THE PRINCIPAL

Greetings Penny Creek Families,

Welcome back! It has been so wonderful to see all of your smiling children walking around our campus. They are so eager to learn!

Many of our students arrive and depart from Penny Creek on assigned school buses. For those families that transport students to and from school by cars, we have designated specific arrival and departure options. Student safety is our number one priority here at Penny Creek and we ask that you read through and follow each of the parking lot safety guidelines.

When **driving** through our parking lot we ask that you do the following:

- Keep your speed limit at or below 5 mph
- Be aware of your surroundings when pulling in and out of a parking spot
- Be cautious of pedestrians
- Park in designated areas

When walking through our parking lot we ask that you do the following:

- Use crosswalks and sidewalks when they are available
- Do not cross between cars, especially parked cars
- Hold the hands of your children or keep them very close to you
- If crossing near the ferry lanes, wait for the crossing guard to escort you
- Use the sidewalks on the west end of campus and do not cross between cars in the kiss and go area
- When parking on the east end of campus for parent pick up, use the cross walk in the front of the school

Everett Public Schools News

Many records and documents in Everett Public Schools are available to the public. Parents and other citizens have the right to ask the school district to view or have copies made of records defined as "public" under state and federal laws including their own student's records and public records about discipline of school employees.

Everett Public Schools public records requests are handled by the district's finance and business services office. Records can be requested by writing that office at PO Box 2098, Everett, WA 98213, sending an email to publicrecords @everettsd.org or calling 425-385-4150.

Your student's records are confidential

Everett Public Schools takes very seriously its duty to protect student records and privacy. Student transcripts and other education-related records are protected by multiple security measures. Only those teachers, administrators and other staff members who work directly with the student and have an educational need to know about the student have access to individual student records. Staff members are expected to maintain confidentiality about information contained in a student's records.

Vaccination requirements

Students in kindergarten through 12th-grade need 2 doses of Varicella (chickenpox) vaccine or have a health care provider document that they have already had chickenpox. Review vaccination requirements for your child on the Washington State Department of Health website.

Safety tip line

Do you or your student have a concern about someone who may be experiencing bullying or harassment? Or perhaps heard a rumor about someone bringing a weapon or drugs to school? Report it! You can talk directly with your school's office or you can call, text or email your concern.
