This November voters elected two new members to the Everett School District Board. April Berg will fill position 2, the seat vacated by the retirement of longtime school board director Carol Andrews. Berg lives in Mill Creek and is a planning commissioner for the city. She has six children, two university graduates, two in university, one at Henry M. Jackson High School and one at Heatherwood Middle School



Andrew J. Nicholls will fill position 1, the seat held by Jamyang Dorjee Nhangkar who was appointed to the board in September 2018. Nicholls is a research social worker with the VA Puget Sound Medical Center and has two children who will soon be entering school in the district's north end.



## Lunch payments are easy with the app



Want to see your student's lunch balance and pay a balance from your phone? If you're logged into the district's mobile app, you can find and pay your student's lunch balance under your student's info. An icon inside the app also gives a shortcut to deposit funds for your student's lunch account. To make a payment, look for the green chef's hat icon.

available in the online iTunes® and Google Play® app stores. Once you've downloaded the app, log in to "student info" with your LMS password to see student-specific information for each of your children.

- 3. Log out especially after using shared computers

Dear Madison Elementary parents,

On April 28, residents in the Everett School District will have the opportunity to make a decision on a bond measure for our schools.

This \$317.4 million capital bond will help ensure equitable access and opportunities for all students, increase safety and security, fund facilities and tools necessary for STEM career pathways, and ensure students have enough room to learn by adding permanent classrooms throughout the district.

All the projects on this \$317.4 million capital bond can be accomplished without an increase to your school district tax rate. Currently you pay \$4.87 per \$1,000 assessed value on your home. If this bond passes, you will be paying \$4.79 per \$1,000 assessed value on your home.

After talking with many of you, I know you are interested in the facts about the upcoming bond so you can make an informed decision when you vote. You especially want to know how the levy will impact our programs here at Madison Elementary. If this bond passes, we will be getting an entirely new school!

- 84,000 SF, two-story replacement school that will remain occupied during construction
- Includes 5,000 SF covered play area, new play areas, play equipment and grass field
- New parking and parent drop-off/pick-up loop
