Personalized Pathway

Personalized Pathway Requirement courses lead to specific post-high school career or educational outcomes chosen by students based on their interests and HSBP. The flexibility of these 3.0 credits provides students an opportunity to include courses, including CTE courses, that align with post-secondary goals and is intended to allow for a personalized focus for the student's learning.



Other Changes

- Certificate of Individual Achievement (CIA) for students with IEPs available through class of 2021
- HS courses taken in MS change from "opt-in" to "opt-out"

- Begin with career skills and interest inventory
- Establish initial career goals and inform 9th grade course taking and transition to high school
- Include information about College Bound Scholarship
- Incorporate results of statewide assessments in ELA, Math, and Science for supports, interventions, and course taking
- Include and inform parents/guardians in native language

HIGH SCHOOL

- Update yearly
- Reflect academic progress toward graduation (transcript review)
- Inform course taking decisions
- Incorporate results of statewide assessments in ELA and Math
- Include resume
- Include and inform parents/guardians in native language

ESSENTIAL REQUIREMENTS

• Include dual credit and CTE programs and eligibility for automatic enrollment in advanced classes

• Align with transition plan for students with IEP

• Include evidence that student is informed about state and federal financial aid programs and supports

- Identify interventions, supports, courses to address learning needs
- Identify graduation pathway(s)
