# Cascade High School 2023-2024 Parking Permit Form

## Parking Permits:

- All motorized vehicles must display a valid permit
- Parking permits must be clearly displayed on the rearview mirror or on the driver's side dash
- Parking permits that are not easily visible may result in a parking infraction
- Students may not give, sell or copy their parking permit for another student. Any student, who gives their permit to, or copies their permit for an unauthorized driver, may have his/her parking permit revoked. Students involved in transferring permits may also be subject to other school consequences including, but not limited to, detention or suspension

## Parking/Driving Guidelines:

- Students must drive in accordance with the traffic laws and in a responsible manner
- Students may not access their vehicles in the parking lot during the school day
- Students may not use their cars to leave school unless they have been properly cleared
- Students are expected to be respectful of all staff, vehicles and other students
- Any observed reckless driving will result in immediate revocation of your parking permit and further disciplinary consequences. Any reported incident and/or violation, which occurred in the parking lot on CHS property, will be investigated and may result in revocation to the violators' permit(s) and further disciplinary consequences
- Students may not park in areas reserved for staff, behind academic buildings, or in the bus loops
- Students may occupy only one parking space and may not park in handicap or no parking zones

## Ticketing/Infractions:

- Vehicles illegally or improperly parked may be ticketed and fined/ towed at your expense
- **Parking infractions will result in a \$50 parking ticket**
- Parking tickets will be obligated to your student account if not paid in 48 hours
- Violations for any parking or school rule may result in school disciplinary consequences and potential revocation of parking permit

## Liability:

- I understand that the school will assist by patrolling the parking areas, but the school will not assume responsibility for loss due to theft, vandalism, fire or other causes
- Neither Cascade High School nor Everett Public Schools will be held responsible if theft, vandalism, or accidental damage occurs
- Do not leave valuable items visible in your car and be sure to lock your vehicle. CHS School Administration reserves the right to revoke a student's permit at any time
