Happy New Year!!! I just want to take a moment to thank all of you for your dedication and commitment to students in the Everett School District. We are truly blessed to have the families, students, staff, educators, and community members that inspire and support each other. There are examples, around the district, of increased rigor, higher expectations, the presumption of competence and collaboration to increase independence, as well as academic and social emotional skills of our students. It truly takes a village.

I thought I would share, in brief, the work Everett School District has embarked on in reference to the **Strategic Plan Theme C: Equitable access to support student learning**.

To educate individual students in their least restrictive environment, we will continue to build a continuum of services that meet the needs of students, support educators, and break down systemic barriers in order to narrow the achievement gap, increase post-secondary success and student independence by building self-advocacy and self- determination.

- A. Offer Inclusive ECEAP (Early Learning); currently we have four sections of co-taught preschool
- B. This year will mark our second year integrating our Transitional Kindergarten beginning Jan. 30.
- C. Continue to grow our inclusive practices across all our elementary and secondary schools by offering more push in services, coteaching and expanding our continuum of services.
- D. Increase community access for our 18-21 Transition Program. To that end, we have a class embedded at the Carl Gibson Everett Senior Center where students are getting opportunities in the community
- E. Increase student independence

Over the past two school years, Special Services has partnered with the Special Education PTSA and district elementary schools to increase equity and access for ALL students. Fifteen elementary schools will be receiving Communication Boards to be installed at their playgrounds. These communication boards support learners who use Alternative and Augmented Communication (AAC) or sometimes just need a little help finding their words, and gives our students a voice and a way to participate in their school community. Communication boards can be used by all learners and supports Part C of Everett Public Schools Strategic Plan.

Boards are currently being finalized and should be delivered to schools this Spring. Schools with boards already installed include View Ridge Elementary and Mill Creek Elementary, check out our youngest learners using them!
