Welcome Parents/Guardians and New Students to Heatherwood Middle School 2019.2020 school year.

Thank you for your interest in attending Heatherwood Middle School! Your registration packet contains information that the Everett School District requires for you to complete in order to attend the 2019.2020 school year. The required documentation consists of:

- **Enrollment form (includes address, emergency numbers and guardian contacts).**
- **Student Housing**
- **Home Language Survey**
- **Heatherwood questionnaire on academic needs.**
- **Proof of address within the Heatherwood service area in the form of a rental agreement or current utility bill.**
- **Standardized test scores from previous district to determine class placement for scheduling.**
- **Certificate of Immunization Records (a signed, completed, Washington State Immunization Form) and health history form.**

Immunization

Under Washington State law, all students must present, or have on file, documentation of their immunization status on or before the first day of attendance. Immunization forms are available at all schools or from the Snohomish Health District, 425-339-5220. The certificate of immunization status must show the month, day, and year the student received all vaccines required. Students may be exempted for medical, religious, philosophical or personal reasons. A licensed health care provider's signature must accompany an exemption for medical or personal purposes. A parent's or guardian's signature is necessary to exempt a student for religious, philosophical or personal reasons. Prior to registering for K-12, please check the [Washington State Department of Health website](http://www.wa.gov/health) for required vaccines. Required vaccines are determined by the student's grade and age when entering school. For more information on scheduling an appointment for vaccinations, contact your health care provider or the Snohomish Health District at 425-339-5220.

In order to help you have a smooth start at Heatherwood Middle school, we ask that you complete the forms (with signatures when needed). Upon the return of the completed forms, the registrar will check to assure you are within our service area and then issue a student number and refer your paper work to a counselor for scheduling. Failure to meet this requirement may result in late registration.
